

CERV budget, objective and structure


CERV Budget 2021 - 2027

CERV Programme – Four strands

Union Values

protect and promote Union values by providing financial support to civil society organisations active at local, regional, national and transnational level

Equality and rights

promote rights, non-discrimination, equality, including gender equality, and advance gender and nondiscrimination mainstreaming

combating racism, xenophobia and all forms of intolerance

protect and promote the rights of the child

protect and promote the rights of people with disabilities

protect and promote EU citizenship rights and the right to the protection of personal data

Citizens' engagement

raise awareness of the common European history

promote citizens' engagement and participation in the democratic life of the Union

promote exchanges between citizens of different Member States (town-twinning and networks of towns)

preventing and combating genderbased violence against women and girls and domestic violence

preventing and combating all forms of violence against children, young people and other groups at risk

What is new in CERV

Union Values (Regranting)

- New call with **50** million euro (2021)
- 2,5 4,5 million euro per organisation
- Re-granting scheme to support small and grassroots NGOs
- → Soon for framework partners (5,6 million euro in 2022)

National Contact Points

- 27 national relays (so far 19 appointed)
- Providing guidance and practical information
- assistance to applicants, stakeholders and beneficiaries

Multi-year work programme

- 2021-2 Work
 Programme with 292
 million euro
- Advanced planning for all calls
- Bigger transparency and earlier information for stakeholders
- → multi-year priorities

Merging of two programmes

- Rights, Equality and Citizenship 2014 2020 – combating racism, genderbased violence,...etc
- Europe for Citizens 2014-2020 citizen engagement and participation, town-twinning, European remembrance

Objectives

- Commemorating defining moments in modern European history
- Raising awareness of common history, culture, cultural heritage and values
- Enhancing the understanding of the Union





Commemoration, research and education about crimes, particularly the Holocaust

- the European and transnational dimension of the Holocaust, its root causes and consequences, and the implications for today;
- to transform research, memorial sites and testimonies of Holocaust survivors into practical educational tools for all parts of society in particular multipliers such as policymakers, state officials and societal leaders;
- tackle the challenge of Holocaust denial and distortion, offline and online.
- Policy priorities
- EU anti-racism action plan,
- <u>EU Strategy on combating antisemitism and fostering</u> <u>Jewish life</u>,
- EU Roma strategic framework on equality, inclusion and participation,

Resistance, democratic transition and democratic consolidation in the EU

- analyse and highlight resistance and/or organised opposition;
- highlight the democratic transition including attempts providing justice for victims;
- focus on how the EU accession influenced democratic standards and practices of the new democracies throughout the accession process.



Eligible entities

- civil society organisations (not-for profit organisations)
- research and archival institutes, universities,
- Educational and cultural organisations, memorial and learning sites
- Member State authorities and public bodies

Actions

- training activities, non-formal education, exhibitions, collection/digitisation of testimonies;
- Diverse target groups and balanced representation (age, cultural and social backgrounds) with a strong focus on multipliers (policymakers, public official, opinion leaders);
- on a transnational level if it adds value to the project (involving the creation and operation of transnational partnerships and networks);

Impact

- add a European dimension to relevant debates on important historical events and moments of recent history.
- counter Holocaust denial and distortion.
- safeguard and make available (including online), archival material, testimonies and authentic sites for education, commemoration and research.
- anchor a common culture of respecting fundamental rights and EU values in the target audience



Gender roles

 the role, representation and perspective of women in these important historical events and developments to allow a more gender-balanced understanding of history;

Local history small-scale historical events on local and community level to create a link between global, continental and local histories;

Unknown history

 historical events that are generally unknown and/or have not been previously a focus of research, however, with important contribution to the historical developments;


Connection to today

 highlight the connection between historical events and the connection to and relevance for today (e.g. negative effect of historical revisionism such as Holocaust distortion and denial).






Submitted applications - Distribution per Country (Coordinators and Partners)

Beyond Robert Schuman's Europe

Project leader: The Bronisław Geremek Foundation

Partner countries: France, Italy, Lithuania, Poland, Czechia

Budget: 96.010 €

The focus on the legacy of 1950 Robert Schuman Declaration and its relevance for modern European societies through the political and intellectual contributions of Europe's Founding Fathers such as B. Geremek (Poland), J. Delors (France), V. Havel (Czechia), J. Giedroyc (Lithuania), A. Spinelli (Italy). The common values arising from the Declaration for both Western and Eastern societies and their understanding of European values.







Contested Histories Onsite

Project partners: Memory Studies Association together with EuroClio- European Association of History Educators

Partner countries: Netherlands

Budget: 98.280 €

This project aims to help citizens better understand and address complex and diverse legacies of Europe's totalitarian past by presenting tours at contested historical sites and developing a toolkit on how to give critical tours.





Portuguese and Spanish Forced Labourers under National Socialism: History, Memory and Citizenship

Project leader: Universidade Nova de Lisboa

Partner countries: Germany, France, Spain, Portugal

Budget: 123.730 €

In a partnership between academic institutions and civil society organisations from 4 countries and counting on 590 participants, FORCED is to cast a light on this shared European past and foster wide reaching reflection on the consequences of totalitarian regimes and keeping alive the memory of their victims.











The Crocus Project: Remembering the Holocaust, learning lessons for contemporary Europe

Project leader: Holocaust Educational Trust of Ireland

Partner countries: Ireland, Slovakia, Romania, Bulgaria, Slovenia, Hungary, Greece, Malta, Italy, Poland, Czechia, Croatia

Budget: 98 280 €

The Crocus Project is an Irish initiative whereby HETI provides yellow Crocus bulbs for young people aged 10 years and older to plant in memory of the 1.5 million Jewish children who perished in the Holocaust and thousands of other children who were victims of Nazi atrocities.



How to be successful?

- Closely align with EU Policy Priorities
- Careful which priority you select (success rate!)
- Strong collaboration with other organisations (consortium requirement)
- Public authority/body civil society organisations partnership encouraged
- Concrete targets and results
- Transnational welcome, BUT only with added value
- Don't wait until last second


