1. *EU-CV Online: technical questions?*

For any technical problem or question related to the EU CV online platform, please refer to the [contact form in EU CV online \(top right of the main page\)](#).

2. *Question on the Application Form: Can I modify my application form, even if the system considers it as submitted?*

Yes, you can update your application until the deadline expires (27/03/2023 at 12.00 midday). All the information you insert up until the deadline will be part of your application.

3. *Question about number of characters in the application form: maximum of characters for each question. Does it mean characters with or without spaces?*

Yes, spaces count as characters.

EU-CV Online counts the characters automatically (you can see the count below the response box). When you reach the limit of characters it will prevent you from adding characters.

4. *Is EPSO account different than EU CV Online account? Do I have to create a new account on EU CV Online?*

Yes, EPSO and EU CV online are 2 different platforms. You need to be registered in EPSO and in EU CV online.

5. *Can I register in any of the profiles in the EPSO CAST Permanent Call for Expression of Interest in function group FGIV?*

Yes, you can register in any profile function group FGIV.

6. *I understand from the call document that pre-selected candidates who do not already have a valid and successful FGIV EPSO Cast will be invited by EPSO to sit a series of tests*

Indeed, pre-selected candidates who do not already have a valid and successful FGIV EPSO Cast will be invited by EPSO to sit a series of tests.

The selection process just started. Your application will soon be evaluated. We do not know yet when the pre selection will be finalised, hence when pre-selected candidates will be invited to the tests.

7. Question about the selection timeline: is there an indicative timeline available?

- The timeline is not yet available, please consult our website regularly for updates.

NB. We do not have updates about the selection EA/III/2023/10 PO managed by HaDEA and which is a different selection procedure. Please address to HaDEA for any updates on the EA/III/2023/10 PO.

- ***I was informed that it is planned a new CAST testing session for 14 June 2024. I would like to know if you plan to invite pre-selected candidates under this call to sit for their test on 14 June 2024?***

No, unfortunately for this selection we are not able to send pre-selected candidates in June.

In order to invite the pre-selected candidates, we should send the request for testing before by the 3rd of May, so we are not ready.

8. I am interested in knowing if successful candidates already having passed the permanent CAST for FG IV need to wait to conduct a potential interview until the pool of people invited to sit the tests finalizes their initial process

All pre-selected candidates will be invited for an interview at the same time (we will wait for the results of the EPSO test of those who did not yet passed the permanent CAST for FG IV).

9. On which information the assessment of my application will be made?

The eligibility check and the assessment of your application will be based on the answers provided to the questions in the application form.

Your electronic E-CV will be used only at the interview stage for reference.

10. What will be my monthly salary?

Your monthly salary will depend from your grade that will be calculated accordingly to the rules set out in Commission Decision C(2017) 6760 final.

The monthly salary for a Contract Agent 3(a), function group IV grade 13 step 1 (lowest possible grade for a FGIV), consists of a basic salary of € 3.982,82 supplemented with various allowances, if applicable (e.g. expatriation allowance, household allowance, dependent child allowance and education allowance).

12. I am on another reserve list of one of the Agency participating to this call? Are the two lists equivalent?

No, each selection procedure gives as result an independent Reserve List.

If you are in another CA reserve list of another agency, you cannot be considered as automatically included in the future reserve lists EA/EPPO/2024/01/CA FGIV Project Adviser.

The same applies if you are in a TA reserve list.
