# Sport PPPA 2024 – Info Session – 20 September 2024

### **Data Protection Notice**

The European Education, and Culture Executive Agency ("EACEA") is committed to preserving your privacy. All personal data are dealt with in accordance with Regulation (EU) No 2018/1725 on the protection of personal data by the Union institutions, bodies, offices and agencies<sup>1</sup> ("the data protection regulation").

On **20 September 2024**, EACEA is organising a **Sport PPPA 2024 – Info Session**. The following Data Protection Notice outlines the policies by which EACEA collects, manages and uses the personal data of the concerned individuals within the processing of registration requests and sending appropriate information to participants.

#### 1. <u>Who is responsible for processing your personal data (data controller)?</u>

The controller is the European Education and Culture Executive Agency, BE-1049 Brussels.

The person designated as being in charge of the processing operation is the Head of Unit A3 Erasmus Mundus, Sport.

#### 2. Which personal data are processed?

#### **2.1 Participants**

Mandatory data for the event organisation: your contact details, i.e. title, first name, last name, position/function, and email address.

Optional data:

- images and voice of the participants;
- the event will be audio and video recorded, and images and video recordings of the event may be published on EACEA website.

Participants are encouraged to provide, to the extent possible, anonymised data to register to the event (corporate email address without name e.g. <u>contact@companyname.com</u>).

# 2.2 Speakers

Images and voice of the speakers as the event will be live-web streamed / audio and video recorded, and images and video recordings of the event may be published on EACEA's intranet webpage hosted on My IntraComm (the European Commission's internal intranet), EACEA website on EUROPA.

### 3. For which purpose do we process your data?

Organising, managing and follow up the event: the primary purpose of the collection of personal data is for the organisation of the given event, in particular for processing registration requests and sending appropriate information to participants such as weblinks of the event as well as a feedback form.

In addition, the purpose of the processing is also for the

- **Recording** of the event: the event will be audio and video recorded for the purpose of publication on EACEA website. We will record on video speakers' presentations and their answers to participants' questions. When asking questions, participants can either use video and/or audio or slido. If they choose to ask questions using video and/or audio, participants will be recorded accordingly. For online events, participants are invited to switch off their micro and camera if they do not want to appear in the recording.
- **Publication:** images and video recordings of the participants to the event (including speakers/moderators) may be published on EACEA's and / or the European Commission's intranet and external websites, as well as social media accounts and the images in the recording can be used by the EACEA and the European Commission for communication purposes.

## 4. Who has access to your personal data and to whom is it disclosed?

Access to your personal data may be given on a need-to know basis to the following recipients:

- EACEA: Staff members of the unit of the controller, Director and Heads of Department.
- European Commission: relevant DGs in particular the Directorate-General for Education, Youth, Sport and Culture (DG EAC).
- Webex Conference Service (WebEx) will process your data for the purpose of organising and managing the event.
- EUSurvey (for participants registering) see <u>EUSurvey privacy statement</u>
- In case of control or dispute, the bodies charged with a monitoring or inspection task in application of Union law (e.g. Internal Audit Service, European Commission, OLAF, EU Courts etc.).

**Use of third-party tool:** please note that the event will be organised using Webex Conference Service (WebEx) which has a contract with the European Commission. Your personal data used for your participation to the event will also be processed by this tool, in accordance with its privacy policy: <u>Webex - DPO Public register (europa.eu)</u>

Please note that in order to deliver the service, Webex Conference Service (WebEx) might transfer your personal data outside the EU in accordance with their respective privacy policies (mentioned above). Such transfer will be made based on standard contractual clauses as part of a contract between the service provider and the European Commission. You can obtain more information on it by contacting the data controller at the above-mentioned email address.

*Use of an online Audience Interaction third party tool:* please note that the event will be organised using Slido to allows participants to interact and ask questions. Your personal data used for your participation to the event will also be processed by this tool, in accordance with its privacy policy which can be found here: <u>https://ec.europa.eu/dpo-register/detail/DPR-EC-06687</u>. Participants not willing to share their personal data with Slido can simply use it by using their organisation's name or other anonymous data to submit questions via the tool.

**General public**: whilst publishing the video and audio recording, participants' personal data appearing on the recording (face, voice, presenters' contribution) will be published on the websites and intranet of EACEA and the European Commission.

## 5. <u>How long do we keep your personal data?</u>

**Mandatory data** relating to the Registration process of the event will be kept for 12 months after the date/closure of the event. However, we may keep information identifying you for a longer period for historical, statistical or scientific purposes with the appropriate safeguards in place.

Video and audio recording will be published on the website of EACEA during a maximum of 12 months after the event, and further kept for 3 years after the date of event.

# 6. What are your rights concerning your personal data and how can you exercise them?

Under the provisions of the data protection regulation, you have the right to:

- Request to access the personal data EACEA holds about you;
- Request a rectification of your personal data where necessary;
- Request the erasure of your personal data;
- Request the restriction of the processing of your personal data;

For the processing of your personal data which is based on public interest under of Article 5(1)(a) of the data protection regulation, please note that you have the right to object to processing of your personal data on grounds relating to your particular situation under the provisions of Article 23 of the data protection regulation.

For the processing of your personal data which is based on your consent under Article 5(1)(d) of the data protection regulation, please note that you can withdraw it at any time, and this will have effect from the moment of your retraction. The processing based on your consent before its withdrawal will remain lawful.

You should also be informed that by virtue of Article 25 of the data protection regulation and of the Internal Rules laid down under Decision of the Steering Committee on internal rules concerning restrictions of certain rights of data subjects in relation to the processing of personal data in the framework of activities carried out by the European Education and Culture Executive Agency dated 22 October 2020 (published on the Official Journal: <u>https://eur-lex.europa.eu/legal-content/EN/TXT/?uri=CELEX:32021Q0317%2801%29</u>), one or several of these rights may be restricted for a temporary period of time inter alia on the grounds of prevention, investigation, detection and prosecution of criminal offences.

## 7. Your right to have recourse in case of conflict on any personal data issue

#### 8. On which legal basis are we processing your personal data?

The Processing of your personal data is based on the following legal basis:

Art. 5(1)(a) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body (to be laid down in Union Law):

- For collecting and processing your data for the purpose of organising and managing the event.
- For processing of your personal data using the above-mentioned third-party tool used to organised the event.
- For communication activities in relation to the event, such as publication of the video recording of the event on EACEA website.

The applicable legal basis under Art. 5(1)(a) are:

- The Commission Implementing Decision 2021/173 establishing the European Education and Culture Executive Agency.
- The Commission Decision C(2021)951 and its annexes delegating powers to EACEA for the management of programmes in the MFF 2021-2027.
- Commission Decision C(2024)4350 amending Decision C(2022) 5057 final as regards the delegation of additional tasks to the European Education and Culture Executive Agency
- Commission Implementing Decision C(2024)927 of 16.2.2024 on the financing of the pilot projects and preparatory actions in the areas of sport, research and innovation and the adoption of the work programme for 2024

Art. 5(1)(d) the data subject has given consent to the processing of his or her personal data for one or more specific purposes:

- Publication on the Internet of the Audio and Video recording of the event.

For participants, if you do not want your personal data appearing into the audio and video recording and being published, you are requested to switch-off your camera and micro during the recording.

If you do not want your personal data to be processed by and transferred to the third party tool, you can also decide to enter non-personal data when registering to the tool used for the event, and to keep your camera and microphone switched off.
