

1. Relevance

- To the **objectives and the priorities** of the programme
- Must be in the **field of sport**
- Proposal should have an **added value at EU level** (EU dimension)

2.2. Partnership & Cooperation

Consortium:


- Relevant **profile** of organisations
- **Trustworthy** & truly **committed**
- **Responsive**
- **Operational capacity** of partners
- Organisations that can help you **reach objectives and solve problems**
- **Digital skills**
- **Sufficient & manageable size** of the partnership



Think of the partners for your project not for your application!

3. Impact

- On **participants and target groups** chosen:
 - Meetings
 - Share of practice
 - Events
 - Concrete benefits and changes
- **Sustainability and impact** beyond the project
- EU funding **visibility**
- Meaningful **outcomes**



Outputs/deliverables

What is a deliverable?

Major output to show progress in the project

Examples:

Guide of best practices, Handbook, Online training course...



Deliverables

Deliverables are key to ensure:

- proper **continuous monitoring** of projects
- good **dissemination of results**
- **transparency** regarding the use of EU funding

...while **respecting data protection** rules



Deliverables

The following deliverables are needed:

- **Implementation progress:** Submission date approximately at mid-term of the project. This document is PUBLIC – Please avoid pictures or personal data.
- **Communication material:** Submission date approximately at mid-term of the project. This document is PUBLIC – Please avoid pictures or personal data.
- **Partners' cooperation and meetings:** Submission date before the end of the project. This document is SENSITIVE and can contain pictures or personal data.
- **Projects outputs (at least one):** to be submitted during the implementation and before the end of the project. These are PUBLIC and must be free of any personal data.

Task and responsibilities



 If you sign the **partnership agreement**, you have to be sure that it is **compatible with the grant agreement!** The amount must be the same as in the proposal.


Award criteria – Scoring

Award Criteria	SCP	SSCP	Events
Relevance	25 p	30 p	30 p
Project design and implementation	30 p	30 p	20 p
Partnership and cooperation arrangements	20 p	20 p	20 p
Impact	25 p	20 p	30 p
Total	100 p	100 p	100 p

Double threshold:

- 50% of each criterion
- at least 60 points in total for SSCP and SNCESE
- at least 70 points in total for SCP

Evaluation of the award criteria



Results

- **Comparative merits** with other grant applications
- Based on the **information provided at application stage**
- Factors **influencing selection results**
 - Level of competition (general quality of applications submitted)
 - Financial resources
- Comparisons with **previous calls are not relevant**

▪ **Success rate 2024:**

SCP	12%
SSCP	22%
SNCESE	16%

Positive results


- **Successful candidates** will be invited to prepare the Grant Agreement in FTOP:
 - PIC validation
 - Bank account
 - Financial capacity documents
- **Be careful with your consortium** → if it cannot be validated, it will question the overall evaluation of the project
- Each year **grant agreement preparations are cancelled** due to problems within the consortium



Negative results

Rejected candidates can:

- Request **additional information** contacting the FMB EACEA-SPORT@ec.europa.eu
- Submit an **appeal on the factual error**.
Unsatisfaction to not be selected is not a valid reason for a complaint.



Common mistakes

Incorrect budget distribution in SNCESE

Type I and Type II

Budget split among all organisations of the consortium – full partners


EU-wide event

Budget only goes to the applicant all other organisations are associated partners in the project

Common mistakes

Excess pages in Part B – Technical description – not evaluated

- 70 pages for SCP-SNCESE
- 40 pages for SSCP
