THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 58/2003 of 19 December 2002^1 laying down the statute for executive agencies to be entrusted with certain tasks in the management of Community programmes, and in particular Article 6(3) thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012^2 on the financial rules applicable to the general budget of the Union, and in particular Article 56(1) and Article 62 thereof,

Whereas:

- (1) Decision C(2013) 9189³ lists the parts of Union Programmes that the Education, Audiovisual and Culture Executive Agency (the Agency) has been delegated to manage, the budget headings for which the appropriations correspond to those parts of programmes and which the Agency is required to implement as authorising officer by delegation and the tasks delegated to the Agency.
- (2) Implementing Decision C(2018) 774^4 provides for the management by the Agency of the 'European Youth Together' initiative in the field of Youth.
- (3) Decision C(2013)9189 should therefore be amended accordingly,

In Annex I to Decision C(2013)9189 Section 2, point 3 is replaced by the following:

'3. SUPPORT FOR POLICY REFORM SHALL INCLUDE ACTIVITIES RELATING TO (ARTICLE 15):

- 1. Part of the implementation of the Union policy agenda on youth through the OMC, namely:
 - Studies aimed at increasing the knowledge of the Youth sector.
- 2. Part of the support for Union-wide networks and European youth NGOs, namely:
 - Civil Society cooperation (Youth);
 - Support for the Eurydice network in the field of youth;
 - The "European Youth Together" initiative.
- 3. Part of policy dialogue with relevant European stakeholders and structured dialogue with young people, namely:
 - Structured dialogue (Youth);
 - Prospective initiatives (Youth).
- 4. Part of the activities related to the Eurodesk network, namely:
 - Eurodesk: Brussels-Link.'
