THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 58/2003 of 19 December 2002¹ laying down the statute for executive agencies to be entrusted with certain tasks in the management of Union programmes, and in particular Article 6(3) thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and in particular Article 56(1) and Article 62 thereof,

Whereas:

- (1) Article 1(12) and (15) of Regulation (EU, Euratom) 2015/1929 of 28 October 2015² sets up an Early Detection and Exclusion System that replaces the Early Warning System and is directly applicable to the Agency, effective 1 January 2016.
- (2) It is therefore appropriate to delete the references to the Early Warning System in Commission Decision C(2013)9189 of 18 December 2013³.
- (3) Decision C(2013)9189 lists in detail the parts of Union programmes that the Agency has been delegated to manage, the budget headings for which the appropriations correspond to those parts of programmes and which the Agency is required to implement as authorising officer by delegation and the tasks delegated to the Agency.
- (4) Commission Implementing Decisions C(2014)6856 of 30 September 2014⁴ and C(2015)6151 of 14 September 2015⁵ entrust the Agency with the management of the "Dialogue with stakeholders National events" activity set up in the field of Sport.

- (5) It is therefore necessary to amend Annex I to Decision C(2013)9189 to include the "Dialogue with stakeholders National events" in the description of the parts of the programme and the tasks delegated to the Agency in the framework of the "Erasmus+" Programme.
- (6) Decision C(2013)9189 should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Decision C(2013)9189 is amended as follows:

- (1) In Article 3(1), letter (j) is deleted;(2) Article 12 is deleted.
- (3) In Annex I, the text of the Parts of the programme which are delegated, Section 3 Sport (Chapter IV), is replaced by the following:

"SECTION 3. SPORT (CHAPTER IV)

- 1. Support for collaborative partnerships;
- 2. Support for non-profit European sport events involving several participating countries;
- 3. Part of support for strengthening of evidence base for policy making, including:
- Provision of part of the studies aimed at increasing the knowledge of the Sport sector.
- 4. Dialogue with stakeholders National events"
